

## **SUMMARY ANNUAL REPORT**

### **For Carbon, Inc. Health & Welfare Plan**

This is a summary of the annual report of the Carbon, Inc. Health & Welfare Plan, EIN 46-1897013, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has contracts with Zurich American Insurance Company, Cigna Health And Life Insurance Company And Affiliates, Kaiser Foundation Health Plan, Inc., Modern Life Inc. dba Modern Health, Aetna Life Insurance Company and Life Insurance Company Of North America to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, and Business Travel Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$5,288,251.
